- Defibrillator update  
The defibrillator has been ordered, delivery time approximately 2-3 months.  
The telephone kiosk has been purchased from BT for £1 and is now in the ownership of the Parish Council.  
A grant application has been submitted to the Pewsey Area Board for £500 and is due to be considered at the meeting on 3 September 2018.  
The Parish Clerk will check the insurance currently in place is adequate.
  
- Overgrown Hedges  
It was noted that the offending overgrown hedges had been cut back since the publication of the Agenda.
  
- “The Battle’s Over” Beacon arrangements  
The beacon will be on Milk Hill on Sunday 11 November 2018.
  - 6.50pm – if possible a bugler to play The Last Post – Mr Pratt will speak to Matthew Wildes to see if this is something he is able to do.
  - 6.55pm – a reading will take place, Simon Hutchings to be asked if he can do this.
  - 7pm – beacon to be lit. It was agreed to draw lots for who lights the beacon, Mr Read will ask Mrs Read to draft a notice to be inserted in the Messenger
  - Mr Hawker will ask the professional photographer who lives in the village if he is available to take official photographs of the event.
  - Weather permitting, one of the marques may be put up near the beacon for refreshments, if the weather is inclement refreshments will be in the Village Hall.
