- 3. Minutes** The minutes of the previous Parish Council meeting held on 6 February 2020 were read, approved and signed by the Chairman, having been proposed by Mrs Tarver and seconded by Mrs Hale.
- 4. Matters arising**
- Road Signage
The Parish Clerk was asked to contact Mr Oatway to see if there is any update regarding the lay-by signage, the “unsuitable for heavy goods vehicles” sign at the junction of Coate Road and the main road, and the white lines on the bend near the church going into the riding stables.
The possibility of hazard lines outside the defibrillator phone box was also raised and the Parish Clerk asked to investigate.
 - Village Letter Pick
It was noted this had not taken place due to Covid19 lockdown restrictions.
- 5. Police Report** It was noted that as at the date of the meeting a Police Report had not yet been received but will be circulated upon receipt by the Parish Clerk to the Parish Councillors.
- 6. Wiltshire Councillor’s Report** As Mr Oatway was unable to attend the meeting there was no report.

- Ratification of Support of Planning Application 20/05303/FUL for proposed change of use of former dairy building to a holiday let (cottage) at The Former Dairy, Church Farm, Church Road, Stanton St Bernard, SN8 4LJ
The above decision made by the Parish Councillors following their site visit on 5 August 2020 was formally approved, it being noted that Mr Bryan Read had declared a conflict of interest and did not participate in the decision.
- Village Skip
A village skip in August during Covid19 lockdown had been very successful.
- Speeding through village
Several villagers had complained about vehicles speeding through the village. It was noted there has been an increase in delivery vehicles due to the Covid19 lockdown and restrictions, with more villagers ordering on-line and having deliveries to their homes. It was agreed that the Parish Clerk would investigate the possibility of a speed restriction with Mr Oatway, and that this be discussed at the next meeting.
- Children's Playground
It was noted new football nets were needed in the children's playground and Mr Dominic Hawker said he would look into the cost involved.
- Any other business
The Parish Clerk was asked to contact the Parish Steward to repair a pothole outside Glenville.
